## **CONCOURSE AB CONNECTOR AND BHS PROJECT Electrical Outages - Concourse A and Terminal A/B Outage #8 in Support of Existing Ductbank Demolition**

---

In support of the ongoing Concourse AB Connector Project (MAA-CO-18-003), an electrical outage is scheduled to take place at Substation B-1 (located in B200C) on the night of Wednesday, January 11 into Thursday, January 12, 2023. This outage will occur between the hours of 11:00 p.m. and 3:00 a.m. In the event the outage cannot occur on this date, a backup date of Thursday, January 12 into Friday, January 13, 2023 has been established.

During this outage, the following electrical loads originating from Substation B-1 will be de-energized and impacts will be experienced in the area of Concourse B and Terminal A/B. The following loads are anticipated to be affected during the outage: Switchboards PPL3B15, PPL2TB25 and PPL3TB211.

### **Impacts anticipated to be experienced during outage:**

- General lighting within the following areas: B Connector and Concourse B; Holdrooms B1, B2, B3, and B4; Concessions corridor at B Concourse; trash shoot lighting B216; MAA Maintenance Room BT145; MER A5; and Substations B1/B2
- BHS outbound screening conveyors OB1, CU-1, and CU-2
- Miscellaneous receptacles AB TSA CBRA area BT125; TSA workstations in AB CBRA/ Reconciliation and OSR Workstation; and TSA Communication Rack in the OSR in AB Screening
- Southwest Gate B2/B3/B4 Lift Station; Podium Gates B2, B3, and B4; Southwest Offices near Gate B3; power and lighting; lighting at Bag Claim hall and Carousels IBB-2, 3, 4, and 5 (emergency lighting will be available); and BIDs at Carousel IBB-2, 3, 4, and 5
- Concessionaires to include Auntie Anne's (Concourse B)
- Unit heaters, exhaust fans, VAVs, cabinet heaters, MODs, and snow ice melt control in the area of Concourse B and portions of AB Concourse

- Restroom impacts by Gate B2/B4 and Arrivals Level near IBB-6: Men's, Women's, and Family Restrooms lighting and power
- Moving walkways ST5493, ST5492, and ST5491
- Elevator ST5502
- Security loads located in BT138 to be supplemented by standby power during outage
- ATS-5 will switch from normal operations to generator power

All tenants should take necessary precautionary measures for the outages noted above. During the power outage, no impacts are anticipated for security systems and life safety systems (to include fire protection and emergency lighting systems).
